Monday 6 June 10am	<p>Match Applications Open:-</p> <ul style="list-style-type: none"> • Create an application for the GNMP Match via the Allocation and Placement Service (APS) Website. (Note: candidates must first register for an account on the PMCV website before applying for the GNMP match). • Enter a maximum of four health service preferences • Nominate two referees • Apply directly to health services listed on the preference list • <u>Victorian distance education candidates only</u> – upload additional information as per Business Rules.
Friday 8 July 5pm	<p>Match Closes for Candidates to:-</p> <ul style="list-style-type: none"> • Apply to participate in the GNMP Match (no extension) • Nominate referees • Upload Distance Education Supporting Documentation (no extension) • Submit health service preferences • Apply to Health Services
Friday 15 July 5pm	<p>Reference Submission Final Date-</p> <ul style="list-style-type: none"> • Final date for referees to submit referee reports (no extension)
Monday 11 – Friday 15 July	<p>PMCV Applications Verification</p> <ul style="list-style-type: none"> • PMCV to finalise all registrations and candidate approvals into the Match
Monday 18 – Wednesday 20 July 5pm	<p>Online Video Interviews</p> <ul style="list-style-type: none"> • Approved candidates record video interview responses.
Thursday 21 – Friday 22 July	PMCV confirmation of interviews and query resolution
Monday 25 July - Wednesday 14 September	<p>Health Services' Selection Process</p> <ul style="list-style-type: none"> • Health services have access to their list of candidates including referee reports and video interview recordings (NB: Candidates' preference order is not disclosed to health services). • Health services conduct their selection process / additional Interviews.
Wednesday 14 September 5pm	<p>Preference Reordering / Withdrawing</p> <ul style="list-style-type: none"> • Final date for candidates to re-order or delete preferences • Final date for candidates to withdraw from the Match

Thursday 15 – Friday 23 September	Health Service Rankings Submission & Confirmation of Positions <ul style="list-style-type: none"> Health Services submit their candidate rankings Health Services confirm final number of graduate places available for matching
Monday 26 – Friday 30 September	Allocation and Placement Process <ul style="list-style-type: none"> Allocation and Placement Algorithm run to match candidates to health services
Monday 03 October 10am	Match Results Published <ul style="list-style-type: none"> Candidates receive an email of their match outcome and / or can log in to see their result. <p><i>NB: Candidates who decline their matched offer are NOT eligible to apply for other positions from another health service.</i></p>
From 03 October 10am	Post-Match Changes <ul style="list-style-type: none"> Health services advise PMCV of the name of any matched candidates who decline a matched position

DATE	GNMP SECOND ROUND MATCH ACTIVITIES
Monday 3 – Tuesday 4 October	PMCV Finalise Second Round Match Configuration <ul style="list-style-type: none"> PMCV complete the transfer of unmatched candidate & health service information to the second-round Match. This includes unmatched candidates' referee reports & video interviews. Candidates' second round health service preferences will be blank.
Monday 3 – Tuesday 4 October	Second Round Match Direct Health Service Applications <ul style="list-style-type: none"> Unmatched candidates are emailed the details of health services with unmatched places. Unmatched candidates apply directly to health services with unmatched places. <p>Note: these can be health services previously applied to and/or health service / graduate programs not previously applied for.</p>
Wednesday 5 – Friday 7 October 5pm	Second Round Match Applications Open <ul style="list-style-type: none"> Candidates enter health service preferences for the health services applied to in their APS account. Candidates can withdraw and not be considered for a graduate place e.g., if failed a subject, placements deferred etc. Candidates failing to enter new preferences by 5pm Friday 7 October will not be included in second round match.
Monday 10 – Friday 14 October	Health Services' Selection Process <ul style="list-style-type: none"> Health services assess the direct applications received. Health services review their new candidate list i.e., all unmatched candidates who preferenced them, including candidates' referee reports & video interviews.

Monday 17 – Tuesday 18 October	Health Service Rankings Submission & Confirmation of Positions <ul style="list-style-type: none"> Health Services enter candidate rankings and confirm final number of places on offer for the second round match.
Wednesday 19 – Friday 21 October	Allocation and Placement Process <ul style="list-style-type: none"> PMCV run the matching algorithm for unmatched positions & candidates
Monday 24 October 10am	Second Round Match Results Published <ul style="list-style-type: none"> Unmatched candidates receive an email of the second round match outcome and / or can log in to see their result. <p><i>NB: Candidates who decline their second round matched offer are NOT eligible to apply for other positions from another health service.</i></p>

Ongoing Unmatched Process

DATE	GNMP UNMATCHED PROCESS
Mon 24 October 1pm onwards	Ongoing Unmatched Process <p>Once the second round match process is completed all remaining unmatched positions and candidates will be managed through a manual process.</p> <ul style="list-style-type: none"> Remaining unmatched places published for general access on the PMCV website. Remaining unmatched candidates and previously not eligible candidates can apply directly to health services listed on the PMCV website unmatched list. Health services have access to the unmatched candidates list and to advise PMCV of candidates who fill positions (PMCV registered or otherwise). <p>NOTE: Registration is NOT now required for these health service applications. The manual process as undertaken in 2021 will be used to place and track changes</p>
