<p>Friday 7 June 10am AEST – Sunday 9 June 5pm AEST</p>	<p>Video Interview</p> <ul style="list-style-type: none"> • Approved candidates complete their (recorded) video interview, via login to their PMCV candidate account.

Monday 10 June – Wednesday 3 July	Health Service Assessment and Selection Process <ul style="list-style-type: none"> • Access List of Candidates who have nominated that health service on their preference list. • Access candidates’ CVs, referee report forms • Access candidates’ video interviews • All health services will conduct their assessment of intern applications from Monday 10 June • Note that some health services may conduct live interviews with shortlisted candidates; these may be scheduled any time between 10 June and 3 July. • Details of health services’ assessment and selection processes (including whether they conduct direct interviews) may be detailed on their websites and are best confirmed directly with the individual health services concerned.
Wednesday 3 July 5pm AEST	Last day for candidates to: <ul style="list-style-type: none"> • Withdraw from the Intern Match • Reorder / Delete Preferences (existing preferences only) • Submit Deferral of Internship online Application form – Category one candidates only.
Thursday 4 July – Wednesday 10 July 5pm AEST	Health Service Rankings <ul style="list-style-type: none"> • Health service administrators submit online a list of candidates in rank order.
Monday 15 July 10am AEST	VRPA Results published <ul style="list-style-type: none"> • Candidates have 48 to accept/decline their offer
Wednesday 17 July 10am AEST	First offer period commences <ul style="list-style-type: none"> • Candidates have 48 to accept/decline their offer
Thursday 1 August 5pm AEST	First offer period close
Friday 2 August	First National Audit of Acceptances and Unplaced Applicants commences <ul style="list-style-type: none"> • No offers of Internship can be made during this period.
Thursday 15 August 9am AEST	Second offer period commences <ul style="list-style-type: none"> • Candidates have 48 to accept/decline their offer
Thursday 5 September 5pm AEST	Second offer period close
Friday 6 September	Second National Audit of Acceptances and Unplaced Applicants commences <ul style="list-style-type: none"> • No offers of Internship can be made during this period.
