

Intern Match 2023 – Summary Report

Intern Positions

There were 973 (FTE) accredited intern positions available in 2023 for commencement at the start of the 2024 clinical year. This was a 4.6% increase from the previous year. The PMCV Accreditation Committee approved 48 additional positions for 2024 commencement.

Position numbers increased most significantly in inner-metro and outer-metro health services.

The following candidates were eligible to participate in the 2023 Victorian Intern Match. Allocation to positions took place in order of priority group categories.

VRPA Priority Group 1 and Priority Group 1 candidates were guaranteed an offer of internship in Victoria if they applied via the Victorian Intern Match and complied with the Match Rules and policies, as per the Council of All Governments (COAG) Agreement (2006).

The DH continued to extend this guarantee to domestic full fee paying Victorian clinical school students applying in 2023 for 2024 internship, as well as graduates in a Commonwealth Supported Place.

These candidates received an offer of internship from a Health Service in their top 3 original preferences. 3 candidates were allocated to their first preference and 2 candidates were allocated to their third preference.

Due to the shortage of candidates eligible for Internship, PMCV allowed Health Service to offer intern position vacancies to IMG candidates.

Health Services also reviewed their positions and reduced the number of intern positions for 2024, there were 11 intern vacancies at the start of the 2024 clinical intern year.
