Thursday 5 June 5pm AEST	<b>Intern applications close for:</b> <ul style="list-style-type: none"> <li>• Candidate registration</li> <li>• Nomination of preferences (candidates can reorder and delete existing preferences until Wednesday 2 July)</li> <li>• Completion of CV form (online)</li> <li>• Submission of supporting documentation to PMCV</li> <li>• Pre-Allocation extenuating circumstances applications</li> <li>• Submission of application for <b>Victorian Rural Medical Scholarship</b></li> </ul>
Friday 6 June 10am AEST – Sunday 8 June 5pm AEST	<b>Video Interview – VRPA and VIA Group 4 candidates only</b> <ul style="list-style-type: none"> <li>• Approved candidates complete their (recorded) video interview, via login to their PMCV candidate account.</li> <li>• Interview responses may be recorded at any time or location during this period – on a computer, laptop or mobile device with the capacity to record video and audio.</li> </ul>
Monday 9 June – Wednesday 2 July	<b>Health Service Assessment and Selection Process – VRPA and VIA Group 4 candidates only</b> <ul style="list-style-type: none"> <li>• Access List of Candidates who have nominated that health service on their preference list.</li> <li>• Access candidates’ CVs, referee report forms</li> <li>• Access candidates’ video interviews</li> <li>• Details of health services’ assessment and selection processes may be detailed on their websites and are best confirmed directly with the individual health services.</li> </ul>
Wednesday 2 July 5pm AEST	<b>Last day for candidates to:</b> <ul style="list-style-type: none"> <li>• Withdraw from the Intern Match</li> <li>• Reorder / Delete Preferences (existing preferences only)</li> </ul>

Thursday 4 July – Wednesday 10 July 5pm AEST	<b>Health Service Rankings</b> <ul style="list-style-type: none"> <li>Health service administrators submit online a list of candidates in rank order (VRPA and VIA Group 4 candidates only).</li> </ul>
Monday 14 July 10am AEST	<b>VRPA Results published</b> <ul style="list-style-type: none"> <li>Candidates have 48 to accept/decline their offer</li> </ul>
